Please be sure to include the "ship to" address. All PO's and "PURCHASER'S ACCEPTANCES" should be emailed to your sales representative.

For privately or publicly funded capital improvement projects, it is also our policy to receive a completed Notice to Owner Information Sheet (attached) prior to shipping the order.

Upon credit approval by our credit department, invoices will be issued with Net 30 day terms. Otherwise, payment is due prior to order being processed and materials shipped.

Payments received late will be subject to interest payments at the rate of the higher of the state allowed maximum or 18.5% per annum. Please allow 3-5 business days for credit check and review. PLEASE PROVIDE AN EMAIL ADDRESS FOR EACH REFERENCE – THIS SPEEDS UP PROCESSING!

Advance payment for materials can be made via check or credit card. Should you wish to pay for your order with a credit card, payment must be made **PRIOR** to materials shipping. For your convenience, we accept VISA, MasterCard, and Discover. We request you fax or email our orders even if you intend to pay with credit card to ensure accuracy of your order.
